Objectives

The current survey accomplishes two main objectives:

- 1.To find the current status of women in the shipping Industry;
- 2.To examine the psychological effects of women working in the Shipping Industry.



Methodology

- Participants
 - WISTA members
- Population
 - approximately 2678 members, worldwide.
- Sample (min)
 - sample of 10% (316 replies)
 - minimum required responses per branch: 5
- Actual Replies:
 - 390 answers (with a response rate of 120.25 %)
 - some branches did not reach their quotas
- Timeframe
 - June-August 2017.




Limitations


- With a very small statistical afforded error of 0.5 % nationality and branch are coincide;
- The tested sample provides reliable results but is limited to WISTA members ONLY;
- Some obtained partial results could not be analysed in conjunction with others;
- Duration of the survey number of questions;
- Willingness of the members to participate.




WISTA membership (2678) per geographical area




Actual Responses (390) per geographical area

Age of the respondents












Marital Status







Do you have children?



How did you end up in this career field?




Were you interested in serving in this career field?






If you replied yes to the above question please explain why






How many hours do you spend at the office?




Net monthly salary range (in US\$)






How many years of work experience did you have before your employment with your current employer?






Do you believe that your current job provides you with social recognition?






Do you believe that your current job covers your expectation before you have joined the company?





How many men are in the decision making matrix of your company?






How many women are in the decision making matrix of your company?




Which are the problems most likely to happen to women in maritime career at sea?

- WISTA members work on a large extent at law or legal related firms, as managers in shipping companies/ ship management companies, and as consultants and in ports.
- WISTA members tend to serve the industry from medium to high level of the organizations echelon.
- Respondents tend to be in the 30-50 range of age.
- Women are highly educated and most do not have shipping education background.
- Most are married and have children.



- Survey participants have started working in the industry either by accident or they choose to work.
 - For example in Europe, the trend is that the women tend to work in shipping 50%-50%, either by accident or it was their choice. But all of the respondents tend to eagerly want to serve the industry not for the monetary gains but instead for the challenge and the acquired knowledge
- Respondents tend to work more than 40 hours per week, but they are highly compensated.
- Those who work in legal related professions seem to be compensated better than the others.

- The majority of the respondents
 - have been working for more than 10 years in the field,
 - are faced with social recognition
 - According to the ILO data the average monthly wage for women is US\$ 1,442 (in all economic activities) with comparison with the weighted average of WISTA members salary of US\$ 3,700.
 - are getting what they expected from their job.



- In a man's world decision making,
 - women do not share equal opportunities with their male counterparts'
 - more is expected for them than men;
 - without the level of mentoring men have;
 - The trend is uniformly spread to all geographical areas of the current survey.
- In the scale of 1 to 5, women are relatively happy (2017 survey) despite of all the issues referred above;
- Segregation is not under formal control with policies in the industry.
